Festival Map, Booth numbers, and additional details will be sent out no later than Monday October 3rd.

The festival board reserves the right to accept or reject any item. Show hours are from 10 AM to 3 PM. **Exhibitors must keep their booths open at all times during show hours.** Absolutely no vehicles will be allowed on the grounds for pack up until after 5:00 PM. Each exhibitor must bring their own display tables, shelves, or anything that is needed. No drugs are allowed on the grounds. **Each exhibitor is responsible for making sure their trash is carried off before leaving the grounds.** There are dumpsters located on the grounds for your convenience.

No refunds will be given unless the festival is canceled due to dangerous weather.

All vendors are responsible for collecting and reporting their own sales taxes.

FEES: All exhibitors' booths, both individual and organizational, will be charged a fee of \$50.00.

FAQ: Booths are all approximately 12'X12'. **Tents will not be provided.**

Checks are often deposited in bulk; your check may not be cashed immediately. There is no online payment process.

You must print and submit your paper application with a check or money order.
